If you have any concerns about the health and safety of a child at this educational setting or feel that something may be troubling them, you should share this information with an appropriate member of staff straight away.

Some issues, for example, a child's appearance, hygiene, general behaviour can be shared with any teacher or member of support staff in this setting. Do not worry that you may be reporting small matters- we would rather that you tell us things which turn out to be small than miss a worrying situation.

However, if you think the matter is serious and may be related to a child protection concern, where the child has been harmed or is at risk of harm, for example, physical, sexual, emotional abuse, neglect, domestic violence or radicalisation you must talk to one of the safeguarding team. Ask any member of staff to find them and ask them to speak to you straight away about a confidential and urgent matter.

Any allegation or disclosure involving someone who works with children in a paid or voluntary capacity must be reported directly to the Head teacher or Deputy Head teacher, unless it involves them and then it should be reported directly to the Chair of Governors Mrs Elaine Morrissey.



Headteacher: Justine McEniff

Responsible for implementing policies and procedures, allocating resources to the safeguarding team and addressing staff safeguarding concerns.

Designated Safeguarding Person (DSL): Justine McEniff

A member of the leadership team with appropriate training who is responsible for dealing with safeguarding issues, providing advice and support for staff, liaising with the local authority and working with other agencies.

Deputy, Designated Safeguarding Leads (DDSL):

Debbie Jackson, Paula Harkness and Mickey Davies

Members of staff with the appropriate training to effectively deputise for the Designated Safeguarding Lead.

Special Educational Needs Coordinator (SENCO): Mickey Davies

A member of staff who provides advice, liaison and support for school staff and other agencies working with pupils with special educational needs and or disablilities and their parents and carers

Family Liaison Officer: (FLO): Debbie Jackson

A member of staff who addresses difficulties which prevent a child from reaching their potential, provides social, emotional support for children to enable them to overcome these barriers, supports parents and carers.

Designated Lead for Looked After children (LAC): Debbie Jackson

Promotes the educational achievement of LAC, helps staff understand the issues that affect how they learn and achieve. Ensures appropriate staff have the information they need.

On-line Safety Coordinator: Charley Kirkham

Maintains and develops and maintains an on-line safety culture in school.

Safeguarding Governor: Elaine Morrissey

Ensures there are appropriate safeguarding policies and procedures in place, monitors whether they are being followed and together with the GB remedies deficiencies and weaknesses that are identified.

Chair of Governors: Elaine Morrissey

Takes the lead in dealing with allegations of abuse made against the Headteacher and other members of staff when the Headteacher is not available, in liaison with the local authority and the Diocese of Shrewsbury. Implements safer recruitment practices with the Headteacher.
